MANAGER COMMENTARY

The UK stock market rallied sharply in the first few days of September before losing most of these gains during the rest of the month. Political uncertainty remained high thanks to twists and turns in both the build-up to the US election and Brexit-related developments. Bond yields rose, with inflation data (particularly in the UK) picking up somewhat.

Evenlode rose +0.5% compared to +0.5% for the UK market and +0.4% for the UK All Companies sector. The most positive contributors to fund performance were Microsoft and Victrex. Microsoft released strong first quarter results, reporting particularly good progress in its cloud offering. Victrex also released a reassuring trading update. Despite headwinds in some of its end markets, Victrex continues to generate strong cash flows whilst steadily investing in long-term growth. The most negative contributors to performance were Unilever and Astrazeneca. Unilever shares fell following third quarter results that demonstrated a very mixed consumer environment globally. Shares in Astrazeneca fell following some negative newsflow from Astrazeneca's head and neck cancer pipeline. We continue to view both Unilever and Astrazeneca as attractive long-term investments (currently yielding approximately 3.5% and 5% respectively).

The most significant change to the portfolio during the month was the removal of SABMiller following its takeover. Elsewhere we topped up several existing positions including Unilever, Fidessa, Page Group and EMIS. Our focus remains on biasing the portfolio towards companies that enjoy a strong competitive position, robust balances sheets and good potential for long-term growth in cash flows. Despite a difficult backdrop, these characteristics give us confidence in the fund's ability to continue producing a healthy dividend stream to investors.






SECTOR ALLOCATION (%)
