## MANAGER COMMENTARY

Evenlode Global Opportunities slightly underperformed its comparator benchmark, the MSCI World Index, in June. Market volatility<sup>1</sup> has been steadily declining since the peak in early January, as participants adapt to increased uncertainty over the direction of travel. The MSCI World Index has now risen almost 9% year-to-date<sup>2</sup>, supported by encouraging narratives about cyclical sectors, particularly semiconductors and consumer durables. This is offset by continued weak economic indicators, an inverted yield curve, and ongoing contractionary central bank monetary policy. We remain interested observers, seeking to insulate the portfolio against a range of outcomes rather than placing active wagers on any specific outcome.


This month we exited two positions, Synopsys and LVMH. These operate in the semiconductor and consumer discretionary sectors, respectively. Both shares have risen materially ahead of the broader market and portfolio year-to-date. We actively manage valuation risk and saw more attractive opportunities to deploy capital. Both companies remain within our investable universe, and we will continue to monitor them closely.

We entered two new positions in the month, Johnson & Johnson (J&J), the US pharmaceutical and medtech giant, and Beiersdorf, the German skincare company. J&J mitigates the perennial pharma concern of loss of patent exclusivity on key drugs with the breadth of its drug portfolio and its broad medtech business. Beiersdorf is best known for the Nivea skincare and suncream brand. The company has recently revamped its strategy, seeking to bias the portfolio towards attractive growth markets (derma-cosmetics and luxury skincare) and targeting increased ecommerce penetration. The brands convey high pricing power and resilience, allowing the company to continue investing in product improvements through the economic cycle.



June sees the close of the major AGM season at Evenlode when the stewardship team focuses on analysing and voting on AGM resolutions. To do this effectively we follow a detailed analysis process; as we do not use proxy advisors, we analyse each resolution based on the company reports before submitting our votes. As part of our active ownership, we then engage with the company if there are points of concern, if we require further information, or we vote against any resolutions. This year we have decided to combine these AGM promoted engagements with our net zero engagements aiming to increase efficiency for both the companies we engage with and within our own processes. Further to our AGM analysis we also run each company through our ESG risk score matrix where they are given a score from A - E. This allows us to manage companies' risks and maximum position sizes. This risk score advocates for strong corporate governance, social and environmental policies, allowing Evenlode to manage the investments in a responsible and sustainable manner.
