The investment objective of the Fund is to provide long-term total returns with an emphasis on capital growth.

The Evenlode Global Opportunities Fund is appropriate for Retail Investors, Basic, Informed and Advanced. The Fund is appropriate for Investors who are seeking Capital Growth. 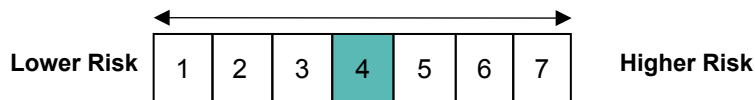

Risk Indicator
